### Elder Care Planner at Elder Voice Family Advocates, MN

Jun 2022 - Present

- Successfully created care plans for 15 clients, which resulted in improved health outcomes and increased client satisfaction.
- Successfully advocated for 5 clients to get the home care services they needed, leading to better quality of life and decreased caregiver burden.
- Conducted 10 educational workshops on elder care planning topics such as long-term care insurance and Medicare/ Medicaid benefits. These workshops led to more informed decision making by attendees about their own eldercare needs.
- Helped 7 families navigate the process of moving an elderly loved one into a nursing home or assisted living facility. This resulted in a less stressful transition for both the family members and the elderly individual.
- Provided support to 3 caregivers who were struggling with caring for an aging parent or spouse with dementia. This included providing resources, referrals, and emotional support, which led to improved caregiver well-being.

- Negotiated and created contracts with 15 new in-home care providers, increasing the number of available service providers by 25%.

- Developed a marketing strategy that increased awareness of our services by 30% within the target demographic.
- Trained 5 new staff members on best practices for working with seniors and their families.
