## Employment History

### Mental Health Social Worker at North Dakota Department of Human Services, ND

Jun 2022 - Present

- I successfully advocated for a client who was seeking disability benefits and as a result, the client received \$1,000 per month in benefits.
- I helped a client develop coping skills to deal with their anxiety which resulted in the client's anxiety level reducing by 50%.
- I provided weekly therapy sessions to 10 clients suffering from depression which resulted in 8 of those clients no longer meeting criteria for depression.
- I created and implemented an after-school program for at-risk youth that met twice a week and served 15 kids. The program had a 95% attendance rate.
- After 6 months of working with me, one of my clients who suffered from PTSD was able to reduce her number of panic attacks by 75%.

### Social Worker at North Dakota Association of Counties, ND

Aug 2021 - May 2022

- Negotiated out-of-court settlements in 85% of cases, saving the state \$250,000 annually in litigation costs.
- Wrote successful grant proposals that resulted in \$1 million in new funding for social programs.
- Developed a new program that reduced recidivism rates by 20%.
- Led a team of 12 social workers who provided services to 1,500 clients per year.
- Trained other professionals on effective interventions for at-risk youth.
