## EMPLOYMENT HISTORY

### ● Security Administrator at Smith & Wesson, MS

Apr 2022 - Present

- Led a team of 4 in developing and implementing new security protocols that reduced companywide breaches by 72%.
- Coordinated with the IT department to install firewalls on all company servers, which prevented over 1.5 million cyber attacks in the past year.
- Worked with HR to create a data security training program for all employees that has resulted in 0 data leaks in the past 6 months.
- Developed an incident response plan that was successfully executed when our systems were hacked last month, limiting damage and preventing future attacks.
